

Scope of work of the Management structure

Management structure bodies (NAO SO/NF) monitor and supervise the effective functioning of the management and control system under IPA in terms of providing legal and regular expenditure, through monitoring and reporting on:

- Changes of internal control framework related to legal base, organizational setup, key positions, procedures, etc.
- Administrative capacities of IPARD bodies
- Performance of system and certification OSCs
- Financial implementation flow
- Audit findings implementation and follow-up reporting



Overview of ICF changes: legal base, procedures, key management positions

- Extension of the implementation of the budgetary commitment 2018 under the IPARD II Programme by one year (N+4), until 31 December 2022;
- Law on Agriculture and Rural Development was amended and adopted in December 2021;
- Changes of IA and MA procedures based on audit findings and recommendations and operational experience;
- Changes in key management positions:
- Head of the Management Structure
- Head of the IPARD Agency
- The Working Group for monitoring of the Action Plan and reporting to the EC, was established.



Main subjects of OSCs: Measures 1,3,7, irregularity management, horizontal issues, project approval processes, payment approval processes, IA OSCs before project and payment approval, including follow-ups of the previous NAO SO findings.

National Fund performed one certification on-the-spot check according to the Annual plan.

All results of OSCs are recorded in NAO SO OSC reports, and elaborated in the relevant Progress report annexed to the Annual management declaration sent to the European Commission on 14 February 2022.

In accordance with the NAO SO annual OSC plan, six OSCs are envisaged to be performed in 2022 that will cover main operational processes (project approval, payment approval, on-the-spot check performance, visit to the recipients, horizontal processes). NF annual OSC plan, envisages one certification OSC.



- Implementation of the IPARD II programme, after a long accreditation process, began in the middle of the programme cycle
- Half of the implementation time was marked by COVID 19
- Strengthened administrative capacities, now prepared for acting according to EU procedures
- Agricultural producers, who expressed great interest with 3177 requests for project approval, gradually adapted to EU rules through this process







An increasing number of requests

Improve efficiency by strengthening human resources, additional training, increased supervision, and weekly monitoring

Process efficiency

Procedures that are easier to follow and clearly defined documentation that users are obliged to submit

Challenge of new market conditions

Support for customers facing unfavorable investment conditions, such as increased construction material prices and equipment and machinery shortages. Manage a large number of project modification requests

Limitations of the legal framework

Amendments to the Law on Agriculture and Rural Development, as well as the rulebook for implementing measures

Access to finance

Advance payment

Field controls in new circumstances

Use of modern technologies for efficient work in pandemic conditions







Advance payment

- Providing legal framework through amendment of:
 - Sectoral Agreement,
 - Law on Agriculture and Rural Development,
 - Rulebooks for implementation of IPARD measures 1, 3 and 7



- Advance payment of up to 50% of the approved funds is enabled for the applications that are contracted after 1 November, as well as for all ongoing submissions
- 5 million Euros estimated effect of realization of advance payment, especially within Measure 3
- 18 advance payment requests, and 9 paid requests with 1,01 million Euros
- A bank guarantee covering 110 percent of the approved advance amount
- The possibility of advance payment utilizing various security mechanisms such as mortgages for physical persons is expected to be established in the second half of 2022.


Precisely defined deadlines at each stage of the procedure

- Due to the COVD pandemic, the deadlines for the procurement of machinery have been extended from 90 to 365 days
- The deadlines for application supplementation have been set, and they now range from 8 to 20 days

Mandatory documentation is prescribed

 Filled application form, proper offers, business plan, and inventory of movable and immovable property















Strengthening the capacities






APPLICATIONS PER SECTOR, TYPE OF INVESTMENT AND REGION:



(For Fruit, Vegetable, Viticulture and Other Crops Sector: EUR 5,000 - 700,000; For Milk, Meat and Egg Sector: EUR 5,000 - 1,000,000.)

Recipient can receive a total support of maximum EUR 2,000,000 of public support under this measure through IPARD III Programme (EUR 1,500,000).



MEASURE 1 - Investments in physical assets of agricultural holdings - specific eligibility criteria

MILK SECTOR:

- AHs with minimum 30 (20) and up to maximum 300 cows, at the end of the investment;
- AHs with more than 300 cows at the beginning of investment are eligible for investments in:
 - manure storage capacities,
 - on-farm energy production from renewable sources and
 - improving biosafety measures.





MEAT SECTOR:

- AHs with 30 (20) 1,000 cattle, and/or 200 (150) 1,000 sheep and/or goats, and/or 30 400 sows, and/or 200 (100) 10,000 fattening pigs and/or 1,000 10,000 turkeys and/or 300 3,000 geese and/or 5,000 (4.000) 50,000 broiler chickens per tour, and/or having a registered facility for keeping/breeding of heavy lines parent flocks at the end of the investment;
- AHs with capacity of more than 1,000 cattle and/or more than 1,000 sheep and/or goats and/or more than 400 sows, and/or more than 10,000 pigs and/or more than 10,000 turkeys and/or more than 3,000 geese and/or more than 50,000 broiler chickens per tour, at the beginning of investment are eligible for investments in:
 - manure storage capacities,
 - on-farm energy production from renewable sources and
 - improving biosafety measures.





MEASURE 1 - Investments in physical assets of agricultural holdings - specific eligibility criteria

FRUIT SECTOR:



- AHs with eligible investments of more than EUR 50,000
 (2 20 ha of soft fruit and 5 100 ha of other fruit);
- AHs registered in the Register of producers of fruit, grapevine and hop planting material with eligible investments of more than EUR 50,000 (AHs registered in the Register of producers of fruit, grapevine and hop planting material with 0.5 - 50 ha of fruit mother plantation).



VEGETABLE SECTOR:

AHs with eligible investments of more than EUR 50,000
 (0.5 – 5 ha of greenhouses and/or 3 - 100 ha open space production of vegetables).





MEASURE 1 - Investments in physical assets of agricultural holdings - specific eligibility criteria



Cereals and Industrial Crops Sector:

- AHs from 50 to 100 ha of land under cereals and industrial crops at the end of investment harmonized criteria for the purchase of tractors, machinery and mechanisation and
 construction of facilities (2 50 ha for purchase of a tractor, machinery and mechanisation
 and construction and equipping of storing facilities; 50 100 ha for purchase of
 mechanisation and machinery for agriculture production and construction of storing
 facilities and equipment);
- AHs which have **from 2 to 100 ha** of land under hop production at the end of investment;
- AHs which have **more than 100 ha** of land under cereals and industrial crops at the beginning of the investments are eligible for investments in:
 - Construction, extension, renovation, modernisation and equipping of storing facilities, purchase of mechanisation and machinery for conservation and land cultivation.



- specific eligibility criteria

EGG SECTOR:

• AHs with a total capacity of the facility with the minimum of **5,000** and the maximum of **200,000** laying hens in exploitation at the end of the investment (without changes);



AHs with a total capacity of facility with **more than 200,000** laying hens, at the beginning of the investment are eligible for the investments in:

- o replacement of old unenriched cages and or equipment for meeting EU standards regarding animal welfare, facilities and equipment for waste management, wastewater treatment, air pollution prevention measures, construction of manure storage capacities;
- on-farm energy production from renewable sources;
- improving biosafety measures.



VITICULTURE SECTOR:

- AHs registered in the Vineyard Register with 2 100 ha of vineyards, at the end of the investment (without changes);
- AHs registered in the Register of producers of fruit, grapevine and hop planting material with eligible investments more than EUR 50,000.

NEW SECTOR

FISHERY SECTOR:

AHs having at the end of the investment a total capacity of facility of **minimum**10 tonnes of fish annually.



Eligible investments:

- Construction/reconstruction of aquaculture production facilities including investments in infrastructure on fish farms (road network, water distribution, electricity network and distribution);
- Equipment for fish farming and transport, respecting biosecurity and environmental protection standards;

AID INTENSITY

Aid intensity from public sources:

- **50%** of eligible expenditures;
- An additional 10% for investments relating to the waste management and circular economy;
- An additional 10% for investments in renewable energy;
- **Up to 70%** of eligible expenditures for collective investments.

A recipient can claim the support, irrespective of the total value of the investment, for eligible expenditures within the following ceilings: Minimum EUR 20,000 Maximum EUR 1,300,000

(Milk Processing: EUR 10,000 - EUR 2,000,000; Meat Processing, Fruit and Vegetables Processing: EUR 10,000 - EUR 1,000,000)

Recipient can receive a total support of maximum EUR 2,500,000 of public support under this measure through IPARD III Programme (EUR 2,000,000).





MILK PROCESSING SECTOR AND MARKETING:

- The recipient has to be registered in the List of Establishments at the end of investment;
- The recipient is required to have capacity of **3,000 100,000** I of collected milk per day at the end of the investment (without changes).

MEAT PROCESSING SECTOR AND MARKETING:

- The recipient has to be registered in the List of Establishments at the end of investment;
- In case of **slaughterhouses**, eligible are recipients with a minimum daily capacity for: 10 cattle or 50 pigs or 50 sheep and goats, or 500 turkeys and geese or 5,000 poultry **at the end of investment** (without changes).
- In case of cutting and/or processing facilities eligible recipients are with a minimum cutting or processing capacity of 500 kg per day at the end of investment.



FRUIT PROCESSING SECTOR AND MARKETING:

• Eligible investments more than EUR 50,000.

VEGETABLES PROCESSING SECTOR AND MARKETING:

• Eligible investments more than EUR 50,000.

GRAPE PROCESSING SECTOR AND MARKETING:

• The recipient has to be registered in the Vineyard Register with the maximum capacities of annual wine production from **20,000 to 1,000,000 litres** at the end of the investment registered in the Winery Register (without changes).

CEREALS AND INDUSTRIAL CROPS PROCESSING SECTOR AND MARKETING:

- In case of seed processors eligible recipients are enterprises registered in the Register of seed processors;
- Eligible recipients are enterprises with eligible investments more than EUR 50,000.

MEASURE 4 – Agri-environment – climate and organic farming measure

COMMON ELIGIBILITY CRITERIA

- Voluntarily agree to take up for a minimum 5 years agri-environment climate commitments;
- Ownership or right of use of the land parcels on which measure will be implemented at least a minimum of **7 years**;
- Parcels registered in the Register of Agricultural Holdings;
- Mandatory education of recipients before the implementation of accepted commitment;
- Comply with the relevant national minimum standards and commitments specified under each operation;
- Keeping farm record book, with relevant information;
- The minimum eligible size of agricultural land that can be included under selected types of operation is as follow:

Arable Land	Orchards	Vineyard	Meadows and Pastures
1 ha	0.5 ha	0.3 ha	1 ha

• Parcels that contain structures and/or elements that dominate the use of (such as roads, farm buildings, ponds, lakes, dumping areas, abandoned land etc.) shall be deemed as ineligible, except for parcels with a limited number of landscape features, which do not interfere with the implementation of the Measure;

- Map of the parcel from the e-platform "GeoSerbia" or a copy of the plan of the cadastral parcel, with clearly marked boundaries and area of the parcels covered by the commitment;
- Operations shall be implemented on the same parcels for the whole duration of the commitment (no change of parcel location);
- A parcel may only be tied to one operation.

Specific eligibility criteria differ per operation



MEASURE 5 - Implementation of Local Development Strategies - LEADER approach

LEADER approach is an IPARD measure implemented through the implementation of local development strategies, prepared and implemented by the Local Action Groups.

RECIPIENTS

Selected Local Action Groups

Local Development Strategy is a planning document prepared for a specific territory by the LAG for the programming period of the IPARD Programme and approved by the DAP.

NEW

LAG status is acquired by an association in a certain territory in the Republic of Serbia, which includes rural areas, whose founders or members are domestic and foreign natural and legal persons and **LOCAL SELF-GOVERNMENT UNITS**, which is registered in accordance with regulations governing the legal status of associations, which has as obligatory governing bodies the assembly, the board of directors and the representatives, whose obligatory goals are prescribed and to whom the LDS has been approved.

MEASURE 5 - Implementation of Local Development Strategies - LEADER approach

ELIGIBLE ACTIVITIES

"Acquisition of skills, animating the inhabitants of LAG territories" for capacity building and animation of selected LAGs

Implementation of "small projects"

"Cooperation projects" for inter-territorial or transnational projects

Activity will be eligible in the latest phase of the implementation of the IPARD III Programme.





MEASURE 6 - Investments in rural public infrastructure



LSGUs - for projects implemented in settlements with **up to 10,000** inhabitants (98% of settlements of the RS)

ELIGIBLE INVESTMENTS

- Construction and reconstruction
- Purchase of fixed equipment of immovable infrastructure

ELIGIBLE SECTORS

- Water management
- Sewerage system
- Construction and reconstruction roads
- Waste management
- Energy supply





MEASURE 6 - Investments in rural public infrastructure

AID INTENSITY

- Up to **100**% per eligible investment not of a nature to generate substantial net revenue;
- Up to **50%** for other eligible investments in rural infrastructure.
- Minimum value of support per project: EUR 300.000.
- Maximum value of support per project: EUR 400.000.
- Total public support under the IPARD III Programme: **EUR 5.000.000**.

PRINCIPLES REGARDING SELECTION CRITERIA

- Type of investments;
- Number of inhabitants in the settlement where investment is envisaged;
- Level of LSGU development;
- Investment in mountain or areas with difficult working conditions in agriculture;
- Energy efficiency, use of renewable energy sources;
- Investment is located in an area where there is at least one recipient under any investment IPARD measure.





RURAL TOURISM SECTOR

- Construction and equipping of accommodation facilities, as well as secondary facilities (facility/premises for food and beverage tasting; small-scale facilities for sports, recreation, leisure, wellness and education...);
- Purchase of IT hardware and equipment, including software, for activities;
- Purchase of vehicles for activities.

DIRECT MARKETING SECTOR



- Construction and equipping of facilities for storage and sale: on the farm gate, local stores, green markets, restaurants (stands, kiosks and equipment for packaging and labelling of products) and online;
- Purchase of food storage equipment;
- Purchase of IT hardware and equipment, including software, for activities;
- Purchase of vehicles for activities (for transportation, mobile shops etc.).



SMALL-SCALE SERVICES SECTOR



Construction and equipping of facilities in order to provide non-agricultural services, such as:

- repairment of agricultural and forestry tools, machines and mechanisation, motor vehicles, motorcycles;
- repairment of computers and communication equipment, as well as gadgets for personal use and household appliances;
- hairdressing/cosmetic services;
- educational services;
- pet care services and veterinary services, etc.



ELIGIBLE INVESTMENTS

- Construction and equipping of facilities (including renewable energy)
- Purchase of equipment (tools, machines and mechanisation)
- Purchase of vehicles for activities

AID INTENSITY

- 60% of eligible expenditures;
- 70% for investments of young farmers;
- 70% for certified organic producers and
- An additional 10% for investments related to waste management, circular economy and renewable energy;

TOTAL SUPPORT AMOUNT CANNOT EXCEESD 75% OF ELIGIBLE EXPENDITURES.





Minimum and maximum values of public support per project

Direct Marketing Sector

- Construction/reconstruction with equipping related projects: EUR 5,000 EUR 300,000;
- Equipping related projects only: EUR 5,000 EUR 100,000.

Rural Tourism Sector

• EUR 20,000 - EUR 300,000

Small-Scale Services Sector

- Construction/reconstruction with equipping related projects: EUR 5,000 EUR 300,000;
- Equipping related projects only: EUR 5,000 EUR 200,000.

Investments in more than one sector: EUR 20,000 - EUR 300,000.

Total support per recipient under Measure 7 for the IPARD III Programme: EUR 600,000.





Changes in IPARD III programming - II

- Aid intensities modified taking into account new policy priorities, e.g.:
 - 70% for investments made by young farmers and/or organic farmers in physical assets of agricultural holdings and in farm diversification and business development; collective investments
 - additional 10% (not exceeding 75% in total) can be given for investments related to effluent and waste management, renewable energy and circular economy-type investments



Financial Framework Partnership Agreement (FFPA), some changes

- Some new definitions
 - Sustainability of IPA III assistance
- 'Our' Managing Authority is now called: the 'IPA Rural Development (IPARD) Managing Authority'
- The rule of origin disappeared!



Sectoral Agreement, some changes

- Less obligatory on-the-spot verifications and use of 'alternative means'
- Since IPARD II, the scope of 'ex-post verifications' more limited then under IPARD I
- More articles on area-based and animal-based projects
- 2 new measures under IPARD III
 - 12. financial instruments
 - 13. promotion of cooperation for innovation and knowledge transfer



Sectoral Agreement, some changes

- No obligation anymore to make payments to the recipients in the national currency
- New article on force majeure and exceptional circumstances
- New definitions in Annex 4, section 1
- Some amendments in aid intensities + putting upper limits ('shall not exceed')
- Putting upper limits to the EU contribution ('shall not exceed')
- Some amendments in Annex 8 concerning publicity, visibility, communication
